Permission is hereby accorded to the Principal, Modern Ways Model School, Sector 29-C, Chandigarh to start 9th Class from the next academic Session 2007-08 i.e. 1-4-2007 subject to the following conditions:-

1. Trained Staff for 9th & 10th Class be appointed.
2. Proper lab should be established and equipped with apprentice upto secondary classes.
3. Proper Library should be established alongwith books upto secondary classes i.e. five books per student as per C.B.S.E. norms.
4. Salary and D.A. should be paid at par with the teachers working in Govt. Schools.
5. The Schools must follow the Finance Secretary, Chandigarh Administration instruction issued vide Memo No.3365-UTFI (3)-2002/8777 dated 24-10-2002 which is as under:-
 - i) The area of the site shall confirm to the minimum area prescribed by CBSE or ICSE Council, as the case may be.
 - ii) There shall be no relaxation of FAR.
 - iii) The number of students shall be regulated in accordance with the covered area available with the School and no overcrowding shall be allowed.




